#### **BACKGROUND**

The adverse effects of climate change are being experienced by local communities within a wide range of economic sectors in developing countries across Africa and Asia-Pacific. The overall goal of the GEF-funded project EbA South is to reduce the vulnerability of developing African and Asia-Pacific countries to climate change impacts by providing capacity, knowledge and technology support.

The project comprises three components to be implemented over four years (2013-2017), namely: i) inter-regional coordination and capacity building for developing countries to plan and implement Ecosystem-based Adaptation (EbA); ii) inter-regional online EbA knowledge support; and iii) transfer of EbA technologies to pilot countries. The pilot countries for concrete, on-the-ground EbA interventions are Seychelles, Nepal and Mauritania, representing coastal, mountain and arid/semi-arid ecosystems, respectively.

The incumbent will have the following responsibilities under the supervision of the Project Management Unit (PMU):

- Ensure high visibility of the web platform, including marketing of the platform to relevant stakeholders.

- Provide general administrative support.
- Any other task assigned by the PMU/UNEP-IEMP.
